

Building the Climate Change Bridge

"Winning the battle against global warming is not about carbon emissions or net zero carbon. It is not about technology. It is not about some arbitrary date that the world ends if net zero carbon is not met. Winning the battle against global warming is all about water."



Primary Strategies To Build the Climate Change Bridge

- 1. Transfer ocean salt waters to the deserts of the World in sufficient quantities to build a centuries' long runway to control rising ocean coastlines.
 - a) Create (dig) inland seas to transfer the ocean waters into.
 - b) Build pipelines for water transfer.
- 2. Desalinate those transferred salt waters to be used to reverse groundwater and surface fresh water depletion and ultimately increase the World's usable and available fresh waters to 5% of the earth's total water (a 10X multiple increase).
 - a) Build desalination plants and nuclear, solar, geothermal, and/or hydro electric power plants along side the inland seas.
- 3. Use the infrastructure developed in the above to reverse biodiversity loss, desertification and ocean pollution.



Primary Strategies To Build the Climate Change Bridge, Continued

- 1. Build and gain consensus of Federal, State and Local authorities.
- 2. Build a chain of inland seas in North America. Under this plan, the States of Utah, Nevada, California, Arizona and New Mexico would all have one inland sea dug in their deserts. There would also be 2 additional inland seas dug and related facilities built in Northern Mexico.
- 3. Focus our initial projects on:
 - 1. The Great Salt Lake
 - 2. The Colorado River Basin

- Current Desert Land Owners Continue to Own Inland Seas and Own Pipelines:
 - Federal
 - States
 - Local Municipalities
- Enter Into Public Private Partnerships (PPPs) and/or Leases for Lands Adjacent to Created Inland Seas with JM Prophecies (JMP) for Construction of:
 - Power plants and facilities
 - Desalination plants and facilities
 - Irrigation of adjacent lands Forms desertification remediation programs & new agriculture
 - Biodiversity facilities including fisheries, marine research and water pollution remediation
 - Tourism, Residential Developments, Industrial Developments
 - Outgoing Fresh Water Pipelines Systems to Sell and/or Replace Ground and Surface Water Use
